Panel discussion 'UAE and Russia: Shaping the Ecosystem of Trade and Logistics of the Future'

The UAE is an increasingly important trading hub with the potential to significantly increase trade turnover between the CIS countries and the regions of the Middle East, Africa, and Asia. The Economic Partnership Agreement on Services and Electronic Payments (SEPA) between the UAE and the EAEU, signed in June 2025, will further simplify cross-border transactions and reduce barriers to trade. Russia and the UAE have unique opportunities to jointly develop new export corridors and logistics routes. What joint initiatives of Russia and the UAE can lay the foundation for new transit corridors? How do multimodal solutions help redirect global commodity flows?
