Strategic Session 'Sell to Russia: New Opportunities for Indian Business'

Russia and India have had great success in intensifying their relations as part of a particularly privileged strategic partnership. They have achieved this level of bilateral cooperation as a result of an intensive and continuous political dialogue between the leaders of the two states, as well as through the development of practical interaction on a mutually beneficial and long-term basis. Key goals remain diversifying trade, balancing the structure of bilateral trade, implementing major infrastructure and investment projects, developing a system of bilateral settlements using national currencies, and ensuring uninterrupted logistics operations. The main focus is on boosting supplies of Indian goods and services to Russia. How can Indian-Russian trade be assessed at the current stage? How can reciprocal trade flows be increased? What are some of the barriers that are still hindering growth in mutual trade, and how can they be overcome? What Indian goods and services have already won over the hearts of Russian consumers? What are some of the prerequisites and conditions needed to increase supplies of Indian products to Russia? What Indian digitalization expertise is in demand in Russia?

Panel Discussion 'Expanding Food Supplies from India to the Russian Market: Strategies and Outlook'

There is significant potential for increasing exports of Indian foods to Russia. Various types of Indian goods already have a presence on the Russian market, including vegetable curries, ready-made meals, legumes, snacks, and confectionery. The product range further expanded in 2024–2025, when India started supplying Indian butter and milk fat to Russia, and the export of Indian grapes also increased. There are also additional opportunities for supplies from India of nutritious cereals, traditional sweets, and seafood. What are some of the current trends in Russian retail, and what opportunities are they creating for Indian producers? What experience has been gained from successfully introducing Indian brands to the Russian market and vice versa? What kind of Indian products are most promising for the Russian market? What requirements must Indian products meet so they can be imported to Russia? What measures are needed to ensure the uninterrupted transportation of goods? How can Indian products find their way to the shelves of Russian marketplaces? What measures can the government agencies and development institutions of both countries take to support the entry of Indian small and medium-sized enterprises into Russia? What is the outlook for localizing Indian manufacturing in Russia's regions?

The panelists will discuss the prospects for creating a resilient and future ready India–Russia manufacturing corridor, focusing on the two high-potential sectors: technical textiles and automotive manufacturing. Russia's rapid industrial expansion in the automotive, construction, and technical apparel sectors is driving strong demand for advanced textile solutions. This presents substantial opportunities for Indian companies to expand exports, establish joint ventures, and collaborate with Russian OEMs, retail chains and e-commerce platforms. Even so, both nations aim to elevate bilateral trade by leveraging India's engineering and production strengths. Russia's rising need for passenger cars, LCVs, heavy vehicles, electric mobility components and aftermarket parts aligns with India's industrial capabilities and policy frameworks such as Make in India. Russia's import substitution programmes create an environment conducive to deeper Indian participation in local manufacturing. The discussion will also highlight integration of smart manufacturing, including automation, IoT, Al-based quality control, and sustainable production practices, to enhance global competitiveness.

Roundtable 'India-Russia: Building Sustainable Cooperation Chains in Trade and Industry'

India-Russia trade and economic relations are experiencing rapid growth: mutual trade turnover has increased almost sevenfold over the past five years. Today, India confidently ranks among Russia's top three trading partners, while Russia is the second-largest exporter to India. An important stage in the development of the partnership is the qualitative transformation of trade, namely, trade diversification and a shift towards cooperation in hi-tech, high-value-added products. How can the trade imbalance be reduced and the import of Indian industrial goods to Russia be increased (textiles, pharmaceuticals, consumer goods, engineering products)? What success stories and growth points in supplies of Indian industrial products to Russia can we point to? What strategic initiatives can deepen industrial cooperation? How can Indian companies be incentivized to enter the Russian market through the establishment of subsidiaries and industrial clusters? What will be the effect of the Free Trade Agreement between the EAEU and India, and how can the negotiation process be accelerated? How can new logistics corridors help overcome trade barriers?
